<b>Entries open and close:</b>	<p>Entries open on 01 April 2024 at 00h00.</p> <p>Entries close on 30 September 2024 at 23h59.</p> <p>The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.</p>

You will be required to provide all necessary information and documentation required for the registration of the vehicle to the relevant parties involved.</li> <li>4. The cost and arrangement of licensing and registration will be covered. The cost and arrangement of insurance and any other costs are excluded.</li> <li>5. Once the vehicle is registered in your name, you take full responsibility, including the vehicle's insurance.</li> <li>6. <p><b>Eligibility: Who qualifies to take part?</b></p>	<p>This competition is open to all individuals over the age of 18 who live in the Republic of South Africa.</p> <p>Only existing FNB Revolving Loans, FNB Temp Loans, FNB Fusion Credit Facilities , FNB Overdraft Facilities, FNB Loans, FNB Credit Card, FNB Home and Structured Lending, WesBank vehicle finance, Revolving Facility, FNB Connect, DirectAxis Personal Loan and CallDirect Personal Loan customers as of 1 April 2024, and who</p>

	<p>meet the qualifying criteria, as per the notification/message shared with you via APN and/or Short Message Service (SMS) from the promoters during the period 1 April 2024 – 30 September 2024. Customers who are APP enabled will be sent a notification on APP and customers who are not APP enabled will be sent an SMS. Please note that customers that have opted out from direct marketing with the promoter will not receive these notifications/messages.</p> <p>If you reply to an SMS, SMS's will be charged at the maximum prescribed rate. 	<p>f) Any person whose accounts and credit agreements with FNB or FirstRand Bank Limited are not in good standing. This means that none or your FNB and FirstRand Bank accounts and credit agreements should be overdrawn, in excess or be in arrears, or be in default, or be subject to any legal process with FNB or FirstRand Bank. Legal process means any legal proceedings in any court of law involving you and FNB or FirstRand Bank, including but not limited to: collections, liquidation and sequestration proceedings.</p> <p>However, even if the aforesaid disqualified persons participate in the competition or is subsequently disqualified, these competition rules will continue to apply between the disqualified persons and FNB.</p>
<p><b>How to enter?</b></p>	<p>You will automatically be entered into the competition if you meet the qualifying criteria, as per the notifications/message shared with you via APN or SMS.</p> <p>Please note that entry is through an electronic platform. Although the promoters will take all reasonable steps, the promoter will not be liable for any technical problems or any loss, delayed or incorrect entries.</p> <p>The promoters reserve the right to disqualify any entrant suspected of fraud or cheating including without limitations, through the manipulation of code or otherwise frequently falsifying data.</p> <p>You, and in the event of your death, at any point from date of entry into the competition and up until the competition end date of 30 September 2024, will automatically be disqualified from the competition.</p> <p>You, and in the event of your death, your family, dependents, heirs, assignees or any other beneficiaries of your estate, indemnify and hold the promoters and its suppliers harmless against any claim by you, or your partner (if applicable), (whether direct, indirect, incidental, punitive or consequential) of any nature, whether arising from negligence or any other cause, relating to any injury, loss, liability, expense and/or damage which you may suffer, howsoever arising, in relation to your entry into this competition and/or acceptance and/or use of the prize, unless to the extent prohibited in law.</p> <p>The promoters reserve the right to cancel the campaign at any stage if deemed necessary in their opinion, and if circumstances arise outside of their control.</p>

If you cannot be reached after 3 (THREE) attempts, the promoters reserve the right to draw a replacement winner.</p> <p>The promoters will attempt to contact the Monthly prize winners via telephone. If you cannot be reached after 3 (THREE) attempts, the promoters reserve the right to draw a replacement winner.</p> <p>You will be required to provide details and sign documentation required in law to effect the registration and delivery of the prize.</p> <p>If you fail/s to comply with any of these competition rules or the terms of acceptance of the prizes, or if you unreasonably refuse(s) to sign the promoters' winner/s declaration and/or prize acceptance form, or any other documentation required to effect delivery of the prize within a reasonable period as determined by the promoters, you will be disqualified and will forfeit the prize. ### General Rules

#### IMPORTANT – PRIVACY MATTERS

Participants in this competition understand and agree that for us to offer this competition, we may collect and use personal information about participants. This personal information may include your first name, last name, email address, mobile number, ID number and in certain instances your [image](#). #### IMPORTANT – LIABILITY

You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.

You also agree to indemnify the promoter(s) for any loss or damage you suffered because you took part in this competition or received or used any benefit or prize. If you enter yourself, or accept or use the prize or any benefit, you understand that you do so of your own free will.
